**Project Description:** The City of Mercedes is seeking proposals from qualified contractors to replace flooring at City Hall (9,769 sq. ft.) with one of the following options: polished sealed concrete, ceramic/porcelain/natural stone tile, or luxury vinyl tile (LVT). Work will be performed after hours and on weekends to minimize disruption.

#### 2. Instructions to Bidders

**Proposal Submission:** - Proposals must be delivered to the address above by the due date. - Include all required forms and attachments.

Bid Format: - Tabbed sections for Proposal Form, Qualifications, References, and Insurance.

**Evaluation Criteria:** - Price - Experience with similar projects - References - Proposed schedule - Warranty and maintenance provisions

**Addenda:** - All clarifications or changes to the RFP will be issued in writing. - Bidders must acknowledge receipt of all addenda.

**City Rights:** - The City reserves the right to reject any or all proposals. - The City is not responsible for costs incurred by bidders.

**Timeline:** - Project completion: within 120 days of Notice to Proceed.

#### 3. Scope of Work / Specifications



Work Areas: Entire City Hall (9,769 sq. ft.)

Flooring Options: 1. Polished & sealed concrete 2. Ceramic, porcelain, or natural stone tile 3. Luxury vinyl tile (LVT)

Requirements: - Existing Floor is concrete - Prepare substrate per manufacturer recommendations. - Conduct moisture testing and perform repairs. - Install flooring per manufacturer and ANSI standards. - Provide mock-up of 100 sq. ft. for approval. - Provide warranties: materials and workmanship. - Work scheduled after hours/weekends to minimize disruption.

The Contractor shall be responsible for maintaining the project site in a clean and orderly condition at all times. Upon completion of the work each day, all debris, waste, and surplus materials shall be removed from the site.

The Contractor shall also be responsible for the proper disposal of all old materials, waste, and debris in accordance with all applicable local, state, and federal regulations. Disposal shall be at an approved landfill or recycling facility at the Contractor's expense.

No additional payment will be made for cleanup or disposal. The project will not be considered complete until the site is cleaned to the satisfaction of the City of Mercedes.
